#### **NCARB Retires the Rolling Clock Policy**

The National Council of Architectural Registration Boards (NCARB) announced earlier this year that its rolling clock policy, which placed a five-year expiration date on passed divisions of the Architect Registration Examination (ARE), was retired on April 30, 2023. It has been replaced with a new score validity policy, which bases the validity of passed ARE divisions on exam versions (such as ARE 4.0 or ARE 5.0) rather than a set time frame. Under the score validity policy, a passed exam division will remain valid throughout the delivery of the exam version under which it was taken, as well as the next exam version. NCARB determined that the rolling clock policy was an unnecessary impediment to licensure and unnecessarily restrictive, given that many current exam items were originally developed under ARE 4.0 and were simply restructured under ARE 5.0 content areas. ## **Sanctions Issued for ARE® Candidate Misconduct**

NCARB announced in July 2023 that six candidates were sanctioned for violating the Architect Registration Examination® (ARE®) Candidate Agreement, ranging from copying and sharing exam questions to, in some cases, attempting to sell exam questions online. Further, all of the sanctioned parties utilized the exposed questions in advance of taking at least one division of the ARE. Sanctions included a public reprimand, invalidation of exam scores, testing authorization suspensions, a requirement to complete ethics education, and, for some candidates, denial of the NCARB Certificate for a period of time. ## **An Important Message from MDEQ**

All public and private, not for profit, schools in Mississippi are required to have a Management Plan maintained by a Mississippi Department of Environmental Quality (MDEQ) certified Management Planner per the Asbestos Hazard Emergency Response Act (AHERA) regulations. All activities that disturb asbestos in these same schools also require the use of an MDEQ certified Project Designer. Both certifications require the applicant to be a licensed Architect or Professional Engineer if the individual was not grandfathered in as of April 1, 1990. As the individuals that were grandfathered are aging out of the profession, there is a need for licensed architects and engineers to fill the void. ## U.S. Businesses Agree that Lowering Licensing Standards Raises Business Risk

The [Alliance for Responsible Professional Licensing \(ARPL\)](#) recently released new research findings showing that businesses are concerned about the weakening of professional licensing standards and the resulting rise in business risk. 84% of businesses surveyed responded that they are concerned that weakening licensing standards will increase public exposure to physical and financial risk. Also, 90% of business decision-makers said that professional licensing protects customers and the public from receiving substandard work, and 92% responded that licensing helps assess qualifications accurately and make hiring decisions with confidence.
