1.			Motion was made by Ms. Jaunsen and seconded by Mr. Bishop to approve the Landscape Architecture Advisory Committee minutes from January 25, and April 5, 2023, and the Board of Architecture minutes from January 24, and February 14, 2023. The motion passed unanimously.
2.	Approval of Certificates		Motion was made by Mr. Bishop and seconded by Ms. Jaunsen to approve certificates issued since the January 2023 meeting (attached). The motion passed unanimously.
3.	Complaint #2020-5	Mr. Cothron provided an update on the complaint and members reviewed the respondent's response letter to the Board of Licensure for Professional Engineers and Surveyors (PEPLS).	Motion was made by Mr. McNeel and seconded by Mr. Barlow to (1) authorize Ms. Word to contact the attorney for the PEPLS Board to request the documents obtained by the PEPLS Board in the course of their investigation; (2) if necessary, submit a formal public records request to the PEPLS Board requesting the documents; and (3) if no response is received, issue a letter to the PEPLS Board requesting an independent code review of the project in question and offering to assist in funding this review. Cothron, Bishop, and Sullivan reported on the results of an informal conference held with the respondent and the respondent's attorney on March 28, 2023, which revealed several mitigating factors resulting in a revised recommendation.	Mr. Jones recused himself from discussion of this item.  Motion was made by Mr. Bishop and seconded by Ms. Jaunsen to accept the revised recommendation to issue a letter of warning to the respondent regarding the architect's primary duty to protect the public's life, health, and property and to take into account all applicable federal, state and local building laws and regulations when designing a project, advising the respondent to complete continuing education courses in building codes (particularly the NFPA 101 Life Safety Code), and remanding the case to the file to be re-opened if further violations of a similar nature occur. The motion passed 4-0.
