		rescind the previous motion. The motion to rescind passed unanimously. Motion was made by Mr. Gallo and seconded by Mr. Mercier to issue an intent to deny letter to Ms. Kemp for practicing landscape architecture without a license with authority to propose a consent agreement providing for a public reprimand and a \$750 fine in lieu of
	,	denial of her application. The motion passed unanimously. Members requested that the cover letter sent with the consent agreement disclose that the normal fine for practice prior to licensure is \$1,000, but the fine was reduced since Ms. Kemp disclosed the practice on her application.

He reported that a meeting will be scheduled with representatives of the Board of Licensure for Professional Engineers and Surveyors to discuss this year's legislation and potential legislation for the 2024 session.
