Additionally, copies of the letters will be sent to the City of Oxford. The motion passed unanimously.

9.	Tire Engineers Decision	Mr. Kilpatrick reviewed the recent decision issued by the United States Court of Appeals for the Fifth Circuit in the Express Oil Change (Tire Engineers) versus Mississippi Board of Licensure for Professional Engineers

EverGreene Architectural Arts Business Name Request		Motion was made by Mr. Durrell and seconded by Mr. Bishop to approve use of the name "EverGreene Architectual Arts," provided that the business utilizes a disclaimer noting that they do not offer or provide architectural services. The motion passed unanimously.
11. Legislative Report	Mr. Cothron reviewed legislation impacting the Board and its Committees. He noted that Senate Bill 2781 (the "Mississippi Fresh Start Act") will require law and rule changes (see item #13 below).	
12. Good Samaritan Legislation	Members reviewed and discussed Good Samaritan legislation introduced during the 2019 session.	
13. Proposed Law and Rule Changes	Mr. Cothron reviewed proposed law and rule changes discussed at previous meetings. Mr. Cothron and Mr. Kilpatrick reviewed proposed law changes required by the "Fresh Start Act."	Members agreed to continue discussion on a law change to allow additional educational pathways to architectural licensure. Members supported adding a preamble to the rules and amending Part 201, Chapter 1 of the rules to allow exam candidates to apply directly to the National Council of Architectural Registration Boards (NCARB) to sit for the Architect Registration Examination (ARE). Members agreed to table discussion of proposed changes to Rules 3.2.4 and 4.5.7, regarding electronic and digital signatures, until the October meeting. Mr. Cothron was asked to research the sealing and signature requirements in other states. Members agreed to table discussion of a proposed change to Rule 3.2.7 until the October meeting. Members expressed support for the other rule changes presented, which will be considered at the July meeting. Mr. Cothron was asked to research fines assessed by other states in the region for comparison purposes.

		Members agreed to discuss law changes required by the "Fresh Start Act" at the July meeting.
14. Funding for Education	Mr. Cothron reported on the results of research into the possibility of providing grant funds to support higher education.	Members agreed to consider a possible law change authorizing grants for education at the July meeting.
 15. Executive Director's Report Third Quarter FY 2019	Mr. Cothron reported on administrative matters and reviewed reports.	
16. Rulemaking Update	Mr. Kilpatrick reported that the Occupational Licensing Review Commission (OLRC) recently rejected the proposed code of conduct rules for the Landscape Architecture Advisory Committee (LAAC) and the Interior Design Advisory Committee (IDAC), although the code of conduct has been added to the rules for the Board of Architecture, effective March 11, 2019. The proposed changes to rules establishing a penalty for late Continuing Education Units were withdrawn since the Attorney General's Office determined that the Board lacked statutory authority to assess a penalty for late Continuing Education Units.	
17. Report on NCARB Committees and Regional Summit	Mr. Bishop and Mr. McNeel reported that the Southern Conference of NCARB is considering changes to the regional bylaws.	
18. AIA-MS Convention Attendees		Motion was made by Mr. Bishop and seconded by Mr. Durrell to designate Mr. Cothron and Mr. Durrell to attend the AIA-MS convention in Biloxi on July 11-13, 2019. The motion passed unanimously.
19. NCARB Licensing Advisors Summit		Motion was made by Mr. Boerner and seconded by Mr. Durrell to authorize Mr. Cothron to attend the NCARB Licensing Advisors Summit in Minneapolis, MN on August 1-3, 2019. The motion passed unanimously.
