1. Minutes		Motion was made by Mr. Bishop and seconded by Mr. Jones to approve the Interior Design Advisory Committee minutes from January 23, 2023. The motion passed unanimously. Motion was made by Mr. McNeel and seconded by Mr. Bishop to approve the Board of Architecture minutes from October 18-19, 2022. The motion passed unanimously.
2. Approval of Certificates		Motion was made by Mr. McNeel and seconded by Mr. Jones to approve certificates issued since the October 2022 meeting (attached). The motion passed unanimously.
3. Complaint #2020-5	Mr. Cothron provided an update on the complaint, which was closed by the Board of Licensure for Professional Engineers and Surveyors (PEPLS) in December 2022. Mr. Cothron has requested the documents obtained by the PEPLS Board in the course of their investigation.	
4. Complaint #2022-14	Mr. Cothron provided an update on the complaint, which is currently under review.	
5. Complaint #2022-15	Messrs. Cothron, Bishop, and Sullivan reported on the results of the investigation and review.	Mr. Jones recused himself from discussion of this item. Motion was made by Mr. Barlow and seconded by Mr. McNeel to issue a letter of caution to the respondents regarding the need to comply with all federal, state and local building laws and regulations governing a specific project. The motion passed 4-0.

7.	Jerry Coleman (Architect #5788) NCARB Certificate Discussion	Members discussed the revocation of Mr. Coleman's NCARB Certificate for lack of compliance with NCARB's Rolling Clock exam policy. Mr. Cothron noted that Mr. Coleman passed all required divisions of the exam, but not within the required timeframe.	Motion was made by Mr. Barlow and seconded by Mr. Bishop to take no action on this item. A vote on the motion was deferred to allow time to contact NCARB for more information.
8.	Question re: Rule 4.5.11 ("Contingency Basis" Rule)	Members discussed a question regarding a potential conflict between an "Availability of Funds" provision in state contracts and Rule 4.5.11.	Motion was made by Mr. Barlow and seconded by Mr. Jones for Ms. Word to respond that the Board's position is that there is no conflict between the "Availability of Funds" provision of state contracts and Rule 4.5.11, and that the Board will take no action against an architect merely for signing a contract with a state agency that contains an "Availability of Funds" provision. The motion passed unanimously.

11.	NCARB Updates	Members and staff serving in leadership roles or on committees provided brief updates on NCARB activities.

Legislative Report	Mr. Cothron and Mr. Kilpatrick reviewed pending legislation impacting the Board, including House Bill (HB) 519, which revises Section 73-1-19 to authorize multidisciplinary firms with landscape architects and amends Section 73-2-5 to declare that regulation of the practice of landscape architecture is necessary in order to safeguard life, health and property.	Motion was made by Mr. Bishop and seconded by Mr. Barlow to approve a change to Section 1, paragraph 3, of HB 519 to delete the requirement for the name of a business entity to contain the name of at least one (1) person who is a registered architect in this state and to instead add language requiring disclosure of the name of at least one (1) person who is licensed as an architect in this state. The motion passed unanimously.
10.	 Executive Director's Report Second Quarter FY 2023 Financial Report 	Mr. Cothron reported on administrative matters and reviewed the financial report for the second quarter of FY 2023.	
12.	Community College Course Acceptance	Members discussed acceptance of architectural courses completed at community colleges, a topic currently being discussed by NCARB.	
13.	Resolution re: Responsible Control	Members reviewed a memo from NCARB's legal counsel regarding the Mississippi resolution on responsible control.	Mr. Cothron was directed to contact Board members for input on the resolution.
14.	Enforcement of State Fire Prevention Code	Mr. Cothron reported that he has been contacted by the Lieutenant Governor's office regarding the Board's letter expressing concerns with codes enforcement in the state, and they wish to set up a meeting after the legislative session to discuss the Board's concerns and recommendations.	Mr. Cothron will follow up with the Lieutenant Governor's office after the legislative session.

15. AG Opinion re: Adoption of Building Codes by the Town of Bay Springs	Ms. Word reported that the AG opinion has been removed from Westlaw and a new opinion will be issued rescinding the previous opinion. Mr. Kilpatrick added that the Town of Bay Springs has elected to continue use of the International Building Code.
