Mr. Cothron presented a question from the respondent about his ability to work under the remote supervision of a licensed landscape architect. Mr. Cothron was directed to reply to the respondent that he may work under the remote supervision of a registered landscape architect as provided by Miss. Code Ann. § 73-2-19(a). Mr. Cothron was asked to stress that the respondent cannot practice landscape architecture or refer to himself as a landscape architect until he has secured a license as a landscape architect in Mississippi. Also, a licensed landscape architect must contract with any clients and seal all documents in accordance with the
